- to provide factual information on the significance of Nordic Ecolabelling in service advertising and marketing material.
- to pay the required fee to the Nordic Ecolabelling organization and other costs in connection with our application for a Nordic Ecolabelling licence and the inspection and on Nordic Ecolabelled services which are demanded by the Nordic Ecolabelling criteria in question or other regulations.
- to indemnify in full the Nordic Ecolabelling organization in the event of claims or other financial expenses incurred by the Nordic Ecolabelling organization as a result of damage caused by the product manufactured and/or sold by the licensee, including faults and defects in the product itself.
- to use the Nordic Ecolabel only while the associated licence is valid.
