



Nordic Swan Ecolabelling's Building Product Database

Nordic Swan Ecolabel tells which products are good for the environment. A building is also possible to become certified with Nordic Swan Ecolabel if it fulfills [the criteria](#) for Nordic Swan Ecolabelled buildings.

The Nordic Swan Ecolabel sets requirements for energy consumption, indoor climate, quality of the building process and the building products and materials used in the building, for instance. All products and materials used in the building need to be inspected and approved by the Nordic Ecolabelling.

Products and materials approved to use in the Nordic Swan Ecolabelled buildings are collected to the Nordic Swan Ecolabelling's Building Product Database. These instructions guide the use of the database.

What is the Building Product Database and what kind of advantages does it have?

The database contains products which can be used in Nordic Swan Ecolabelled buildings. The database contains both ecolabelled products (Nordic Swan Ecolabel or EU Ecolabel) and products that have fulfilled requirements set for Nordic Swan Ecolabelled buildings (listed products).

Building Product Database is aimed at builders of Nordic Swan Ecolabelled buildings and producers of building products and materials. The use of the database saves time and helps builders to find products that fulfill material requirements. The database benefits also producers of building products by making it unnecessary to provide information on products several times.

The database is shared with all Nordic countries.

What kind of products can be added to the Database?

It is only possible to add to the database products to which have been set requirements in the criteria for the Nordic Swan Ecolabelled building.

Product Matrix -table ([Excel](#)) can be used as a tool to check whether products can be added to the database. The Product Matrix also reveals requirements to products and declarations that are needed.

When you open the Product Matrix, choose first "enable editing" in the top and then "select language" in the left -> Select English and go to the tab "product matrix". A column "Nordic ecolabelling portal" reveals if the product can be added to the database.

How products are added into the database?

Producers of chemical products and construction materials get the right to use the database by filling and signing [the user agreement form](#) and by sending it to the one of the Nordic Ecolabelling offices (email addresses are in the application form).

There are no fees in the database.

Manufacturers of products can add products to the portal and see products they have added by themselves. All products in the database are visible to companies which currently are in the process of constructing a Nordic Swan Ecolabelled building.

Listing in the database is valid over the validity of the criteria generation 3. Manufacturers of products have however responsibility to update product's declaration(s) if there appears changes in the product or the regulations related to the product changes.

Primarily products are added to the database by products' manufacturer. For example, importer/seller can add products to the database with the permission of manufacturer providing the manufacturer has signed declarations for the products and they will be uploaded to the database together with the electronic declarations.

Reviewing of products

When the product is added to the portal it gets status "Application registered" or "Request for Application". The product is not yet visible in the database.

The Nordic Ecolabelling reviews products added to the portal regularly but doesn't receive notifications for products added to the portal.

When the product added to the portal is reviewed it will get the status "Listed" and it will be visible in the database with the information of product name, manufacturer, and description. Declarations and other documents provided to the portal are only visible to the Nordic Ecolabelling.

Ecolabelled construction products (always suitable)

Nordic Swan Ecolabelled building must get at least 14-16 points from point-score requirements depending on the type of building. One of the point-score requirements is Ecolabelled construction products. It is possible to achieve even 10 points by using Nordic Swan Ecolabelled or EU Ecolabelled construction products in the following way:

- > 10 % of products in one product category are ecolabelled: 1 p
- > 50 % of products in one product category are ecolabelled: 3 p

Product categories are for instance indoor paints, building boards, acoustic panels, and floor coverings (more information in the appendix 13 of the criteria).

Ecolabelled building products stands out in the database with a status of "Approved" and with a Nordic Swan Ecolabel or an EU Ecolabel logo in the right side.

EU Ecolabels granted outside Nordic countries can be found in the EU Ecolabel Product Catalogue ([ECAT](#)). ECAT contains all the products that have gotten an EU Ecolabel in some country among the system. Products can be searched from the register either by a product category, a product or a manufacturer name or a license number.

How can the listed products be communicated to customers?

The products listed in the building products database may only be described in the customer communication with the following sentence: (The product is) listed in the portal for building products that can be used in Nordic Swan Ecolabelled buildings.

Creating of own logos for products listed in the building database and using them in communication or marketing is not permitted.

Communication relating to the listed products is strictly regulated because ecolabelled products – Nordic Swan Ecolabelled or EU Ecolabelled - may also be available for the same use. These products meet strict requirements and have been inspected by Ecolabelling organizations.

The characteristics of the listed products are based on the declarations provided by the manufacturer in accordance with the requirements of the criteria for small houses, apartment buildings and buildings for schools and pre-schools. Nordic Ecolabelling has checked the declarations, but the products are still not Nordic Swan Ecolabelled. The Swan logo may not be used in connection with listed products or say that the products are Swan Labeled.

Using the Database

How can products be added to the database?

Product Matrix -table can be used as a tool to check whether products can be added to the database and which requirements apply for each product.

After receiving user name and password, get familiar with [the instructions](#) of the database.

Product Groups and Product Types of the Building Product Database and declaration types (Product Subcategory) for the products can be seen collectively in the appendix 1 of this instruction.

Products are wished to be added to the database with the GTIN number if possible.

If there is a need for a declaration type which is not possible to select, additional declarations can be added as a pdf format to the section of "Upload documentation" in end of the electronic declaration.

Multi-component products

If the product is formed of multiple components, declarations are needed to fill in for all the components.

Wall element, for example, is formed of concrete and insulation material:

- Appendix 7 and safety data sheet are needed for additives of concrete.
- Appendix 9 is needed for the insulation material.

Requirements for different materials and components can be seen in the product matrix.

Adding several products to the database at the same time

If you are adding several products to the database contact Nordic Ecolabelling to receive a table in which you can fulfill basic information on your products. Instructions for filling the table are presented in the appendix 2.

Table is read to database by Nordic Ecolabelling and after this you can declare your products in the database. See instructions for the multiple product declaration in the next page.

Multiple Product Declaration

To declare multiple products at the same time, following product information fields need to be filled in for all products: "Product Name", "Status", "Product Category" and "Product Subcategory".
